### Re-Enrollment Information

**Open enrollment and Re-Enrollment for the next school year 2017-2018 will be the first two weeks in December.** All of our current students are guaranteed enrollment for next year, if they turn in this application during those two weeks. After this two-week period, priority may no longer be given to our current students. If you have not re-enrolled by December 16<sup>th</sup>, your student's place for next school year is not guaranteed.

Siblings of students may also register at this time. Please contact the office for an application. During the enrollment period, if we receive more new student applications than we have space available, a lottery will take place and students will be placed into the class or on a waiting list according to the order their name was drawn. As spaces open, students from the waiting list will be added to the class.

Anyone enrolling after the open enrollment period will be enrolled on a first come first serve basis. Waiting lists will be established as well. Everyone that enrolls in December will be notified in January if their child has a spot in our school for next year via a Congratulations or Waiting List letter.

Please register your child by filling in the information below and submitting this application along with a \$50.00 deposit, during open enrollment from December 1, 2016 through December 16, 2016. This deposit is applied to your student's material fees for next fall. Deposits are refundable. Check or Money Order Only.
